**AMENDING RESOLUTION 2019-17  
REVISING THE 2019-2020 COUNTY ROAD IMPROVEMENT PROGRAM**

**WHEREAS**, the Board of County Commissioners acted in its regularly scheduled meeting on May 6<sup>th</sup>, 2020 to Amend Resolution 2019-17 to reflect the roads which will be worked on and funded under FY20 Local Government Road Fund and adopt the **County Road Improvement Program** for 2019-2020; and desires of the state Department of Transportation (NMDOT) to accept the same; and

**WHEREAS**, it is the desire of the County Commission to prioritize road improvements based on road conditions, classification and the needs of its citizens; and

**WHEREAS**, the NMDOT has requested that Valencia County utilize all available funding sources at its discretion for County road improvements; and

**WHEREAS**, it is to the benefit of the citizens of the County for the County Commission to upgrade its road system, and endorse an aggressive Road Improvement Program; and

**WHEREAS**, Valencia County and the New Mexico Department of Transportation entered into a Cooperative Agreement for Contract No. D18267; Control No. HW2-L300235 with a total project cost of \$184,904.00; Valencia County's proportional matching share shall be 25% or \$46,226.00 and New Mexico Department of Transportation's share shall be 75% or \$138,678.00. Valencia County shall pay all costs which exceed the total amount of \$184,904.00.

**WHEREAS**, Valencia County and the New Mexico Department of Transportation entered into a Cooperative Agreement for Contract No. D18271; Control No. HW2-L300236 with a total project cost of \$153,724.00; Valencia County's proportional matching share shall be 25% or \$38,431.00 and New Mexico Department of Transportation's share shall be 75% or \$115,293.00. Valencia County shall pay all costs, which exceed the total amount of \$153,724.00.

**WHEREAS**, Valencia County and the New Mexico Department of Transportation entered into a Cooperative Agreement for Contract No. D18272; Control No. HW2-

DocuSign Envelope ID: 6DBBF9D8-7D0B-49B8-BAE6-75400905581A. 3,333.00; Valencia County's proportional matching share will be 25% or \$58,333.00 and New Mexico Department of Transportation's share shall be 75% or \$175,000.00. Valencia County shall pay all costs which exceed the total amount of \$233,333.00.

**WHEREAS**, the originally proposed road improvements on Carrejo Lane & Laughlin Drive are no longer a priority as these road improvements were funded during the previous year LGRF road fund.

**NOW THEREFORE, BE IT RESOLVED**, by the governing body of Valencia County that:

1. The 2019-2020 **County Road Improvement Program** is of a high priority and is predicated off current needs and road conditions
2. The County will enter into Cooperative Agreements Control Number HW2-L300235, HW2-L300236 and HW2-L300237 with the New Mexico Department of Transportation for LGRF Project for year 2019 – 2020 to improve the roads defined under the attached Change in Route Request's within the control of Valencia County in Los Lunas, New Mexico.
