WHEREAS, the Board of County Commissioners has established various boards and advisory committees to assist with the management of County business; and,


WHEREAS, on February 19, 2025 this Board approved Resolution 2025-18 amending appointments of the board and committee members of the Valencia County Commission; and,

WHEREAS, the Commission has determined that Resolution 2025-18 requires amendment to update a current appointment on a board.


